We seek to provide a Biblical-based model of care offering prayer, Bible devotion and scripture reading, hymns/sing-along, and special speakers throughout the day. Our center is smaller and has a European feel that is warm and inviting! Our staff to participant ratio is 4:1 over state mandates. We provide exceptional and personalized care and treat each person like family. Reducing daytime sleep and increasing activity during the day equals thriving for our family members. When persons with dementia are in a social setting, they perform at a higher level of functioning.

We also serve Veterans and have a contract provider agreement with the Veterans Administration. We also work with long-term care insurance companies so your loved one's daycare expenses can be covered. We also offer monthly caregiver support groups every 3rd Saturday of the month from 10:30 am to 12:00 pm. This
